## 2019 / 2020 Student Vehicle Registration for a Parking Permit

All students who, at any time during the current school year, plan on driving & parking their vehicle in the student parking lot during regular school hours must complete this registration form (front and back) and have their Parent or Guardian sign it (even if student is 18 years of age).

**RETURN THIS FORM TO THE ATTENDANCE WINDOW BETWEEN THE HOURS OF 9:00 - 11:30 AM AND 12:10 - 3:15 PM ALONG WITH ALL OF THE FOLLOWING:**

- 1) A **CHECK** for \$25.00 (NON REFUNDABLE) made payable to "Deer Lakes School District" - **NO CASH WILL BE ACCEPTED!!** You will be charged an additional \$12.00 if your check is returned due to insufficient funds, you will be placed on the debt list and your parking permit will be suspended until the debt is paid in full.
- 2) Student's PA Drivers License (must be valid)
- 3) Valid PA Registration card for **ALL** vehicles you are registering
- 4) Proof of valid auto liability insurance for **ALL** vehicles you are registering

*No permits will be issued unless all of the above items are presented and this form is completed & signed by both a parent/guardian (where indicated below) and the student (on the back)!!*

**IMPORTANT – READ BELOW!!**

### STUDENT AGREEMENT

1. I understand that the \$25.00 parking permit fee is NON-REFUNDABLE, no matter what the circumstances are.
2. I understand that my 2019/2020 DLHS student parking permit must be displayed from the rear view mirror of my registered vehicle with the numbers facing outside at all times while the vehicle is on school property, during school hours.
3. I understand that vehicles parked on school property without a legitimate and properly displayed 2019/2020 DLHS student parking permit may be fined and/or subject to being towed away at the owner's expense.
4. I understand that I am the only person permitted to drive my registered vehicle on school property.
5. I understand that my vehicle must have a valid State Registration, valid inspection/emissions stickers, and be properly insured at all times or I will not be permitted to drive and/or park anywhere on school property and must surrender my 2019/2020 DLHS student parking permit to the Principal or Assistant Principal immediately.
6. I will park my vehicle promptly upon arrival at school in a legal parking space in the STUDENT PARKING LOT, exit the vehicle immediately and report directly to school. I will NOT, at any time, park in any of the parking spaces located around the school building which are reserved strictly for DLHS faculty.
7. I will not visit or move my vehicle from its' parking space during school hours, including lunch time, except in cases of emergency for which special permission must be granted by the Principal or Assistant Principal.
8. I will at all times operate my vehicle in the interest of the safety of others and in accordance with the PA Vehicle Code & Act 81, or risk having my 2019/2020 DLHS student parking permit suspended or revoked.
9. I will not transport other students in my vehicle to school or home (except immediate family members) without permission from the parent(s)/guardian(s) of both the driver and passenger(s) or school administrators and in accordance to Act 81.
10. I understand that with the privilege of driving to school, there is also the responsibility of reporting to school on time. I understand that if I accumulate Unlawful Tardies, I may be denied purchasing a 2019/2020 DLHS student parking permit or, if one was already issued, I will have my 2019/2020 DLHS student parking permit suspended or revoked (see below).

PER THE DISCIPLINE POLICY LISTED IN THE STUDENT HANDBOOK:

- Suspension of driving privileges for 30 school days (days that school is in session) on the 6<sup>th</sup> Unlawful Tardy
  - Suspension of driving privileges for 60 school days (days that school is in session) on the 10<sup>th</sup> Unlawful Tardy
  - Loss of driving privileges for remainder of the school year on the 15<sup>th</sup> Unlawful Tardy
11. I understand that accumulated in-school and out-of school suspensions or leaving school without permission will result in my 2019/2020 DLHS student parking permit being suspended or revoked.
  12. I understand that if my driver's license is suspended or revoked, then I lose the privilege of parking/driving on school property at any time and must surrender my 2019/2020 DLHS student parking permit to the Principal or Assistant Principal immediately.
  13. I understand that vehicles parked on school property may be subject to searches if reasonable suspicion exists without prior notification.
  14. I understand that any violations of any part of this agreement may result in possible fines, my vehicle being towed at my expense, suspension or revocation of my parking permit & therefore my privilege to use school parking facilities during school hours.

*I have read the above Student Agreement. I understand the agreement and agree to abide by it. If I do not abide by it, I accept all consequences and disciplinary actions, as listed in this agreement and per the Student Handbook.*
